PENALTIES²

- \$25.00.....Returned Payment/Item Fee
- \$6.00.....Returned Payment/Item Handling Fee
- \$50.00.....Reset meter during business hours (after disconnection for non-payment)
- \$250.00.....Unauthorized Use Fee (per occurrence)
- \$1,000.00.....Illegal System Connection Fee

- Charges for meter testing will be credited to customer if meter is inaccurate.
- A late fee equal to 10% of monthly charges will be added to charges not paid by the billing due date.
- The monthly minimum water charge will increase by 2.5% annually from FY 2016 through FY 2019.
- The monthly variable water charges will increase by 9.0% annually in FY 2016 and FY 2017 and 8.75% in FY 2018 and FY 2019.
- Except FYE 2018, the monthly minimum wastewater charge will increase by 1.0% annually from FY 2016 through FY 2019.
- Except FYE 2018, the monthly variable wastewater charges will increase by 4.25% annually through FY 2019.
- Wastewater connection fee does not include any necessary road crossing.
- If service is extended to a new development and includes installation of all infrastructure excluding the meter and reading unit, a voucher of \$750 (water) and \$640 (sewer) will be provided that is redeemable during application for service.
- Tap fees and systems fees for connections larger than 6-inches will be based on actual costs and estimated demand, respectively.
- Charges for Main or Fire Line taps 6" or greater are based on actual costs with a minimum of \$3,000.
- Sewer system fee is based on water meter size.
